ELEMENT CREDIT: To receive exam element credit, the candidate must bring one of the following items to the exam session: an old license copy, a letter from the FCC stating which license class was held, a copy of the entire page from a *Radio Amateur Callbook* showing the license class, call sign and the book's publishing year (Unfortunately, *Callbook's* published before 1967 did not list the license class). Remember, the burden of proof lies with the Candidate not the VEC or VE Team.

CT = Pre-03/21/1987 Technician licenses. Applicant will receive credit for Element 3 but must hold a current Technician license or must pass a Technician Element 2 exam to earn a General license.

CL = Expired General and Advanced Licenses. Applicant will receive credit for Element 3 but hold a current Technician license or must pass the Technician Element 2 exam to earn a General license.

CL = Expired Extra Licenses. Applicant will receive credit for Elements 3 and 4 but must hold a current Technician license or must pass the Technician Element 2 exam to earn a Extra license.

EXAM FEES: Every applicant must pay the exam session application fee. If a candidate fails an element and wants to re-test for the same element, an additional fee will be required. VE Teams may retain a portion of each exam application fee for prudent and necessary exam session expenses. LICENSE RENEWALS AND CHANGES FEES and ARRL MEMBERSHIP FEES: VE Teams may not retain any portion of the processing fee from license renewals and changes or memberships as these are not fees related to an exam session.
