FAQ # 232 What's the best way to transfer net control? There may be a time when you need to have another operator take over as net control. It may be the end of your shift during a long deployment or a storm may be approaching your station. Propagation may be changing or you may be called away for an important task. You may be experiencing some intermittent equipment failure. You get it. Sometimes you just need to transfer duties.

Ideally, you'll have a back-up station ready with an operator who has been following the net and keeping track of its activities. That's why we all should do that. If you don't have someone designated, you'll need to ask for a volunteer. It works best to ask a specific station whose signal is good and who has some net savvy.

First, give the incoming NCS a list of traffic pending with its precedence and who's holding it. Second, pass along a list of liaison stations and, third, send a list of stations who are in the net. Be careful to get the calls right. Arrange for a time to meet with the new net control to combine your net report.

Announce the transfer and restate the purpose of the net. Log the time the change is made. If you can, stick around a few minutes in case there are questions.

A smooth transition is especially important when a net is busy or needs to extend over a long time. The process is worth practicing. If we're ready, we can do it without a hitch – confirming our ability, out flexibility, and our sustainability. 73 – K9LGU/STM
