FAQ # 230 Are we scared of what we may be called on to do when providing communications for served agencies? Not a ghost of a chance. Here's a report uninterred from six years ago. Not much has changed.

We're not spooked by changes in format from NTS to ICS-213 or back. We've practiced both forms and all the proper procedural words to get a message across exactly right. If we can, like any good witch, we run a *spell* checker when we write a message. Then we pace our delivery so the receiver isn't rushed into boo-boos.

The feeling that we haven't practiced being a net control doesn't haunt us. We've volunteered on local and section nets. We've shadowed experienced net controls, kept net records, and learned their tricks and treats, even when we're not serving as NCS. Public service events have given us plenty of practice. Witch means – we're not a fly-by-night organization.

We've gotten to know staff from the National Weather Service and forwarded storm data – meeting the right criteria using the right format. We've worked with our Emergency Coordinators, our Emergency Managers, hospital staff, law enforcement officers, and Red Cross personnel in non-emergency situations. We've built mutual respect. We know the Incident Command System. We don't get buried in the details. We're willing to work the graveyard shift.

We're not afraid, because we've already dealt with the hobgoblins of static, interfering signals, pressures of time, and equipment failures. We know even a skeleton crew of good operators can do good things. Make no bones about it. Even if our message pumpkin needs repair – all we need is --- a pumpkin patch, 73 – K9LGU/STM
